TREASURERS POSITION

As you are no doubt aware, Austin has resigned from the position of treasurer and the Club is in need of a new treasurer. As this meant that no formal accounts for the club were presented at the June meeting. Austin had completed the payment of all accounts due and rolled over the investment account prior to his handing over the books. I presented a statement to the meeting based on the available documentation (Dick had some and I had some) which showed the estimated financial position of the club as at 30th May. Bill Lampe and myself have since examined the books and begun the reconciliation with the bank statements. This will be presented at the AGM.in the annual accounts.

CLUB MEMBERSHIP AND CLUB AFFILIATION with VMAA

Club membership is now due for 2010-2011. The meeting decided to leave the fees as of 2009-2010. These are Seniors \$75; Pensioners \$65; Juniors \$25 and with a joining fee for new members of \$20. This means that TOTAL FEES would be (including VMAA, insurance etc.) SENIORS \$179; PENSIONERS \$169; JUNIORS \$87. The joining fee remains at \$20 for new members. Note that while the club is not increasing its fees, VMAA, MAAA and insurance charges may increase. If you pay the total fee now then there could be an additional levy once these additional components are known. It may be better to hold off until VMAA, MAAA and insurance charges are known for 2010-2011. I DO however need the APPLICATION FOR RENEWAL OF MEMBERSHIP FORM which the VMAA requires for registration and Insurance cover by 30th. June. The information you provide on this needs to be collated and transferred to sheets for mailing to VMAA.

Club affiliation with VMAA requires registration details for all members. To provide this I need some information when you renew membership. Attached to this TALEFEATHERS is an application form which should accompany your membership renewal. PLEASE COMPLETE IT AND RETURN IT TO ME ASAP as the deadline for re-registration is 30th. June. Copies will also be available from the clubhouse. If you wish to include payment please attach it to the form or see Dick or myself so that a receipt can be issued.

IMAC

Luke reported that about 30+ will be attending the IMAC weekend. Of the entry fee of \$50; \$10 goes to ASAA and \$40 to the club so it is a really worthwhile money earner for the club. Trophies and prizes have been obtained and surplus drinks from WW11 will be used in the canteen. See Luke if you can assist in the canteen.
